VOYAGE, ESTABLISHING ITS SIGNIFICANT IMPACT ON THE FUTURE OF MARINE TRAFFIC AND RESOURCE DEVELOPMENT IN THE ARCTIC AND SETTING THE STAGE FOR THE CURRENT OIL CRISIS.

ADD TO THIS THE RICHES OF THE CONTINENTAL SHELF, SEABED, AND WATERS, RANGING FROM RARE EARTH MINERALS TO FISH STOCKS. AFTER A SPIKE OF AGGRESSIVE RHETORIC WHEN RUSSIA PLANTED ITS FLAG IN THE ARCTIC SEABED IN 2007, MOSCOW HAS ATTEMPTED TO STRENGTHEN ITS POSITION AS A KEY FACTOR IN DEVELOPING AN INTERNATIONAL CONSENSUS CONCERNING A REGION WHERE ITS RELATIVE ADVANTAGES ARE MANIFEST, DESPITE ITS DIMINISHING MILITARY, TECHNOLOGICAL, AND HUMAN CAPACITIES.

THESE THEORIES TEND TO DISSOCIATE CITIES FROM THEIR NATIONAL AND REGIONAL CONTEXT AND THUS IGNORE THEIR HISTORY, CULTURE, POLITICS AND INSTITUTIONS.
